### **Cat Adoption Agreement**

Our adoption donations vary upon the age and health status of the cat. Our adoption donation covers fees that the rescue pays which usually includes: vaccinations, spay/neuter, food, transport, shelter fees, and supplies including medical bills. We accept cash or credit cards and we do not accept checks at this time.

I hereby agree to the following terms and conditions pertaining to the pet adopted by me from A4TDR:

1. I understand that I am adopting this cat solely as a household pet and it will be kept indoors at all times. If for any reason I cannot keep this cat I will immediately notify and return the cat to A4TDR. The cat shall not be given away, re-homed, sold or surrendered to a shelter or a pound at any time for any reason. I understand that if a family member or friend would like to take ownership of this cat they will be required to apply through A4TDR for the right to adopt. I also understand that all adoption fees are non-refundable and if said cat is returned for any reason the adoption fee is then considered a tax deductible donation.
2. A4TDR makes no guarantee about the cat's temperament, health, age or mental disposition. A4TDR is not responsible for any damages or injuries caused by this animal at any time in any location. You are adopting this pet at your own risk and take full responsibility for him/her at all times. A4TDR will not be held responsible for any veterinary care or bills related to this said cat above after the time of adoption. If your new pet becomes ill within the first ten (10) days after the time of adoption please be sure to call us first before seeing an outside vet.
3. A4TDR may make inquiries about and/or examine the cat at any time. Adopter shall not hold access to any medical records and shall promptly respond to any concerns A4TDR may have about the status or condition of the cat at any time.
4. I agree to provide food, water, shelter, exercise, mental stimulation and routine medical care for my adopted pet including monthly heartworm preventative medication. In the event that I can no longer provide such necessities for this pet I will notify A4TDR immediately so that arrangements can be made for the cat to be re-homed or returned to the rescue organization. I agree not to mentally or physically abuse this pet nor let anyone else do so at any time. This pet should not be in a crate for more than eight (8) hours total each day.
5. I agree to provide a leash, collar and id tag for this pet. If pet is microchipped I agree to keep the microchip tag attached to the collar at all times. Rabies tags should be attached to your pets collar at all times. This pet shall be licensed in your township by the age of six (6) months.
6. A4TDR agrees to accept this adopted cat back into their foster care program as long as there is not an aggression issue and/or major health issue present. If an aggression issue is present the adopter will take full responsibility for finding the cat a new rescue, training and/or other safe placement. Adopter must be able to hold the cat for at least seven (7) days until an appropriate foster home is found or available. If a foster home cannot be found within seven (7) days the

adopter must make appropriate arrangements for the cat until a foster home is found and provided.

7. A4TDR is part of the NJ State Spay and Neuter Program. Our code for this program is \_\_\_\_\_ please go to: [www.state.nj.us/health/vph/pop-control/](http://www.state.nj.us/health/vph/pop-control/) and choose a vet from the participating vet list. Spay/Neuter is done quarterly on January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup> and October 1<sup>st</sup>. You must call to schedule your appointment. This cat will be altered by six (6) months of age or by \_\_\_\_\_ and a certificate of sterility shall be presented to A4TDR within seven (7) days of surgery. If you choose to have your personal veterinarian alter your new pet it must be done by the date above. In no event shall this animal be allowed to breed. It is mandatory to have your current and adopted pets spayed/neutered.
8. I agree to notify A4TDR immediately if my pet becomes lost, stolen or passes away. I agree to notify the microchip company immediately if this pet is microchipped. I will make all reasonable efforts to recover my pet if my pet becomes missing. I agree to not let this pet roam outside of an enclosed fenced in area and I also agree to never leave this pet unattended in any vehicle. I will abide by all local leash and license laws.
9. The adopter agrees to notify A4TDR if they ever intend to euthanize this cat for any reason. A4TDR retains the right to take possession of the animal if they disagree with the reason and/or decision. \*Note\* This does not include situations where a vet has deemed it necessary to euthanize the cat due to irreversible illness or injury.
10. I have never been subject to legal action for cruelty to animals or neglect to animals. I have never owned an animal which has been confiscated by any animal control, humane officer or humane organization.
11. I acknowledge that A4TDR has the right to reclaim this animal and make appropriate arrangements for the cat at any time for failure to comply with this adoption agreement or adoption application. Should an event like this occur adopter will forfeit all adoption fees. Adopter will be responsible for any and all expenses including court costs and attorney fees. This includes fees needed to enforce this contract and reclaim the animal.

Failure to fulfill any of the above terms and conditions will cause breach of this agreement and will authorize A4TDR to reclaim this pet and/or take legal action. This adoption agreement is governed by the laws of New Jersey. All 4 The Dogs Rescue is a registered non-profit 501c3 rescue organization. All donations not related to an adoption fee are tax deductible with a signed donation receipt.

I have read and fully understand this adoption agreement. I agree to fully abide by all terms and conditions stated in this adoption agreement.
