

**FOSTER HOME AGREEMENT**  
**- All 4 The Dogs Rescue -**

---

1. The person(s) agreeing to foster the animal (the Foster Family) will follow all relevant procedures and guidelines (forthcoming) presented by All 4 The Dogs Rescue (A4TDR) or (Agency) regarding the animal being fostered and will make no decision or take any actions regarding the animal's veterinary care (including euthanasia) or placement without prior approval of the Veterinary Chairperson of A4TDR.
2. The Foster Family shall provide the foster animal with humane care and maintain it in accordance with all current state, county and municipal laws and ordinances while the animal resides with the family.
3. The Foster Family shall provide the foster animal with a fully fenced in yard or walk them on a secure leash. Under no circumstance may the dog be permitted to run loose outside, nor shall the dog be kept chained or tied to any object outside. The dog shall not be crated for more than 6-8 hours a day.
4. Dogs shall be kept indoors except for exercise, play and elimination purposes. Cats are to be kept indoors only.
5. The Foster Family agrees to provide the foster animal with a collar and tag, indoor shelter, adequate food and water, care and affection, socialization and daily exercise. They agree to work on house-training, crate-training and leash-training to increase the adoptability of the animal.
6. The Foster Family will provide A4TDR with an honest and accurate behavior assessment of the animal in the home discussing both positive and negative qualities.
7. The animal shall reside at the Foster Family's address listed on this form only and shall not be given to anyone else or placed in any other home or facility without the Agency's prior approval.
8. If the animal cannot be kept by the Foster Family, said Foster Family shall notify the Agency immediately. The Foster Family must give the Agency at least 48 hours' notice to find another Foster Family or to arrange for a return. The animal may not be sold, transferred, surrendered, abandoned or relinquished to anyone without approval from the Agency in writing.
9. The Foster Family agrees to notify the Agency by phone if their foster animal needs to be seen by a vet or has a medical need. The Foster Family agrees to use the vet they are directed to take the animal to and the visit will be covered by the Agency. The Agency will not cover vet bills incurred at outside vets including emergency vets or vets of the Foster Family's choice. You must use a vet that works with All 4 The Dogs Rescue regardless of where you are located.
10. The Foster Family understands that A4TDR has limited information regarding the temperament, breed and habits of the animal. The Foster Family will take all reasonable

precautions (through the use of supervision and common sense) to ensure the animal does not injure itself or anyone else, cause harm or injury to any person, persons, animals or property.

11. The Foster Family does hereby release, discharge and hold harmless A4TDR and any Officers, person, firm or corporation charged or chargeable with liability, administrators, executors, successors and assigns for any and all claims, damages, costs, expenses, less services, injuries, action and causes of action whether known or unknown, belonging to the Foster Family due to any action or occurrence arising out of or in connection with fostering for A4TDR.
12. The Foster Family agrees to be courteous, helpful and honest with potential adopters and to fully cooperate in accommodating those who wish to see the adoptable animal.
13. The animal remains the property of A4TDR and can be removed from the Foster Family at any time. No prior notice is needed if conditions are not met in accordance with this agreement.
14. Should the Foster Family not willingly cooperate with all of the terms set forth in this agreement, the Foster Family agrees to pay any and all expenses, including court costs and reasonable attorney fees, in enforcing the terms of this agreement.
15. All 4The Dogs Rescue will reimburse the Foster Family for all approved purchases accompanied by a receipt. A4TDR will cover all veterinary visits that have been pre-approved once the receipt is submitted. If the Foster Family needs to board the foster animal, they must notify A4TDR at least 7 days prior so that proper arrangements can be made. The Agency will not reimburse or cover pet sitting or outside boarding at a kennel, home or vet's office.

**\*\* Please Note\*\*** If this agreement is marked as a foster to adopt or being used as a safety quarantine agreement, final paperwork must be done in 14 days. No veterinary bills or other expenses will be covered after 14 days from the date of this agreement. All final adoption agreement paperwork must be completed by: \_\_\_\_\_
